# Apply for Housing

The <u>housing application</u> for new students (who do not currently live on campus) will be available starting October 15 at 8am. Housing assignments are made based on the date of the submitted application. The \$40 housing application fee is a one-time, nonrefundable fee to apply for on-campus housing. The \$200 housing pre-payment will be applied as a credit to the fall bill. Housing assignments will be communicated to students via email in late May/early June. # **Register for Orientation**

Destination Kent State is a required three-step orientation program designed to help you transition to Kent State and achieve success. The first step is Destination Kent State orientation. All new students will attend the program in June or July to register for fall classes. During the overnight visit, you will stay in the residence halls, meet other incoming students, meet with an academic advisor to create your fall class schedule, get your Kent State ID and much more.

#### Placement Testing

All new students admitted prior to May 15 must complete required placement assessments no later than June 1. Students admitted after May 15 will still have access to their placement assessments and should complete any required assessments at least three days before attending Destination Kent State. Beginning March 1, incoming students can access their New Student Checklist in their Flashline account to view and take any required placement assessments.
